DENTAL HEALTH BENEFITS OF XYLITOL

 Dental caries is a transmissible infectious disease that is triggered by *mutans streptococci* bacteria. As infants we receive the bacteria primarily from our mothers. As we age, these bacteria live in our mouths, feeding off the sugary substances we eat and excreting acids that cause tooth decay. Curtailing the consumption of sugar as well as stopping the original transmission of S. mutans bacteria are important steps in reducing dental caries.

According to the Academy of Nutrition and Dietetics, the average American consumes about 22 teaspoons of sugar daily, mainly from soft drinks, energy drinks, grain based desserts and fruit drinks. A sugar substitute called xylitol provides all the taste benefits of sugar without its many drawbacks. Xylitol is a five-carbon sugar alcohol compound. It is neither a sugar nor an alcohol. It occurs naturally in plants or can be manufactured from sugar and starches. Xylitol is not an artificial sweetener, but a crystalline carbohydrate which looks very much like sugar. Our bodies naturally produce xylitol and the enzymes to break it down, so there is no chance of any adverse reactions. The use of xylitol increases saliva production and reduces the number of S. mutans bacteria, thereby reducing acid production in the mouth.

Xylitol products include chewing gum, mints, toothpaste, and mouth rinse. The daily use of these products should be recommended to all patients. Most importantly, mothers and infants should be advised to use xylitol during pregnancy and after childbirth in order to reduce the initial transmission of bacteria. Patients should be encouraged to consume xylitol in three to five divided servings throughout the day. For infants, xylitol nasal drops or sprays and xylitol syrup or gel are effective in blocking or delaying the early transmission of bacteria.

When looking to buy xylitol containing products, patients should look for products that have xylitol as the first ingredient on the label. Products that have 100% xylitol, for maximum benefit, include: Spry Mints, Toothpaste, Gum, Oral Mist and Toothgel; Xlear Nasal Spray; Ricochet Gum and Candies; Xylichew Gum and Mints; and Ice Breakers from Hersheys.

Xylitol's Preventive and Therapeutic Benefits:

- ✓ Helps prevent tooth decay by reducing plaque formation.
- ✓ Blocks the acids that demineralize the tooth enamel.
- ✓ Halts the growth of acid producing bacteria.
- ✓ Reduces gingival inflammation.
- ✓ Has a glycemic level of 7, which does not trigger an insulin reaction in the body, making it useful for diabetics.
- ✓ Has 40% fewer calories than sugar.

HEALTHPLEX TO PARTICIPATE ON HEALTH CARE EXCHANGES

The Affordable Care Act (ACA) will fundamentally change the health insurance market and the way that Americans are covered for health insurance. The ACA will create state-based marketplaces called exchanges for individuals and small business owners with fewer than 50 employees to purchase insurance.

Beginning on October 1, 2013, enrollment through the exchanges will begin. People can go online or work with trained "navigators" to see what plans are available and to compare prices and benefits for insurance coverage. Coverage will start on January 1, 2014.

At a minimum, plans offered on the exchange must include Essential Health Benefits (EHB), such as prescription drugs and pediatric dental and vision care. In New York, covered dental procedures will be similar to those covered today under the Child Health Insurance Program (CHIP). Adults are not required to have dental coverage. However, in New York adults will have the option of adding dental coverage for themselves and their spouses. Beginning in January 2014, individual New Yorkers who had coverage through the Healthy New York program will no longer have that option. Instead they will buy one of the many products that will be available through the exchange.

Healthplex will participate in the exchange by administering plans through clients such as: Affinity, Easy Choice, Emblem(HIP), HealthNow(BC/BS), MetroPlus, North Shore LIJ, Oscar and Universal American; and by offering stand-alone dental plans through Healthplex Insurance Company and Dentcare.

What to tell your patients and employees about the new exchange dental plans:

- * Children are required to have dental coverage. This coverage can be part of a medical policy or a separate dental policy.
- * There will be a variety of plans to choose from with varying out-of-pocket expenses.

PREVENTING FRAUD AND ABUSE

Prevention and detection of fraud and abuse is in everyone's best interest. Fraudulent activities contribute to the costs of healthcare, interfere with relationships with patients and affect a dentist's good reputation in the community. Being able to recognize fraudulent activities is the first step in preventing them from occurring.

What constitutes fraud and abuse?



1. Billing for services not rendered.
2. Billing for more expensive services or procedures than were actually provided; commonly known as "upcoding".
3. Unbundling of services.
4. Routine waiving of patient co-pays or deductibles and/or over-billing the insurance company or benefit plan.
5. Performing unnecessary services solely for the purpose of generating insurance payments.
6. Billing for covered services, but actually performing cosmetic services.
7. Falsifying a patient's diagnosis to justify tests, surgeries and/or other procedures that are not medically necessary.
8. Altering claim forms and medical or dental records.
9. Allowing hygienists, assistants or other staff to perform treatments that they are not licensed or qualified to perform.
10. Accepting kickbacks for patient referrals.

According to the National Health Care Anti-Fraud Association (NHCAA), Code D4341 is the most highly abused dental code:
Dentists perform a prophy (code D1110) and then bill for Periodontal Scaling and Root Planing (code D4341).

Examples of common dental fraud and abuse:

- Performing a simple 1 surface filling, but billing as if a 2, 3, or 4 surface composite was performed.
- Billing for full mouth radiographs (code D0210) when only a single periapical, or bitewing radiograph is performed.
- Billing for surgical extractions when simple extractions were performed.
- Billing for composite restorations but performing sealants.
- Billing existing restorations as newly placed restorations when the patient changes insurance carriers.
- Billing for new dentures when existing dentures were repaired.

ACA REQUIRES EMPLOYEE NOTIFICATION

Under the Affordable Care Act (ACA), employers must provide a notice to employees informing them of the existence of the newly formed ACA marketplaces along with information on how to contact the marketplace to request assistance in purchasing coverage should employees choose to do so. Employers must provide a notice of coverage options to each employee, regardless of plan enrollment status (if applicable) or of part-time or full-time status.

The written notice must be provided either by mail or email, in a manner that will be understood by the average employee. The Department of Labor has created model notices designed for this purpose which are available online for printing. One model notice is for employers who offer a health plan to some or all employees and the other is for employers who do not. To access these model notices, go to www.dol.gov/ebsa/healthreform and select **Model Notice**.

NEW YORK MEDICAID ORTHODONTIC RE-CERTIFICATION



In order to continue care of previously approved orthodontic cases, providers must submit updated patient photos (taken approximately 11 months after initial banding) and a copy of patient treatment records/notes.

The annual re-certification feature will be available on the Healthplex website for cases that were originally submitted via the website. Cases originally submitted by mail must continue to be submitted by mail until the website is automated to include previously submitted paper authorizations.

All mailed pre-authorizations and re-certifications must be accompanied with a pre-determination form (i.e. ADA dental claim form) in order for the case to be reviewed.


